Subject: According to rules and regulations of student's free and compulsory education, as per rules of 2010, sub-rule 15 (4), Student's Free and Compulsory Education Regulation Act, school's affiliation letter towards achievement of Objective of Section – 18 of 2009.

Respected Sir/Madam,

As per the application and inspection of the school, we are giving affiliation to THE WHITEFIELD SCHOOL, Bhokhra Dist. Bathinda from Class 1st to 8th. The above affiliation is given according to the following conditions:

1. This affiliation is up to 8th class and anyhow it cannot be extended to further classes.
2. The school will follow the rules and regulations of Student's Free and Compulsory Education Act, 2009 and sub-regulations of Student's Free and Compulsory Education Act, 2010.
3. The school will give 25 % admissions to the nearby poor and weak students and will provide free and compulsory education from their initial class to the last class.
4. According to sub regulations of Section 12 sub- section (2) of the Act provided in para 3, expenditure of the school will be fulfilled. The school will have to maintain a separate bank account for this fulfillment.
5. School will not charge any capitation fees and will not follow any method to make a choice of students or his parents or his guardians.
6. School will not deny admission in case the birth proof of a student is not available and will follow the sub-regulations of section 5 of the Act.
7. School will also ensure that:
 - a. Student will not be struck off and will not repeat the same class until the study is not completed.
 - b. Student will not be punished or mentally tortured
 - c. Student will not be required to pass the board exam until the primary education is not completed.
 - d. Every student will be provided with the report card who has passed his primary education as per rule 25 of the Act.
 - e. Facilities for physically disabled students, according to sub regulations of the Act.
 - f. It is important for teachers to fulfill atleast their educational eligibility under section 23(1). But if the present staff does not fulfill the educational eligibility under the act, must fulfill it within 5 years. Teaching and non-teaching Performa should be attached herewith.
 - g. The teachers must fulfill the responsibilities mentioned under the Act 24(1):
 - h. The teachers will not engage themselves in any private tuition;
8. The school will follow the syllabus declared by the upper authorities.
9. The school will follow the mentioned conditions under section 19. Following are the facilities reported during previous inspection:-

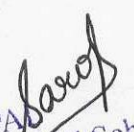

10. No class without affiliation must be run on school's name inside or outside the school premises.
 11. School building or other structure must be used only for progress of study and co-curricular activities.
 12. School is running as per the rules and regulations of the Society Registration Act, 1860.
 13. School is not running for any personal benefit or for benefit of any group or group of people.
 14. The written work must be audited by a certified chartered auditor and audit statement will be prepared according to the rules. One copy of each audit report will be sent to the District Education Officer.
 15. Registration no. of your school is 685. It must be noted and mentioned on the letter head whenever sent to the office.
 16. School will provide the detail time to time whenever demanded by the district education officer and follow the instructions given by District Education Officer to fulfill the conditions of affiliation or to overcome the shortcomings of the school.
 17. Registration for the renewal of institution, if necessary.
 18. Fire safety and building safety certificate. **After expiry of validation of these certificates, school must send it to the office, if the same is not done then process of cancellation of affiliation will be started.**
 19. Medium and language certificate.
 20. The E-roll copy of the salary given to teachers and copy of registry of land.
 21. Map of school building.
 22. Salary according to government norms and list regarding funds received from the students.
 23. List of society members.
 24. Six month salary of the staff from class 1st to 8th must be deposited.
 25. In case the rules and regulations of RTE Act are disobeyed in the future then strict action will be taken as per the rules of RTE Act.

NOTE: The above conditions in serial no. must be fulfilled within 3 months otherwise affiliation will be revoked.
